FROM THE ARNOVA CO-CHAIRS

The ARNOVA Board has recently had some discussion about broadening the scope of themes and topics treated in our annual conferences and publications. For many years, some members have criticized ARNOVA for its overly technocratic emphasis and narrowness, feeling that the full range of global university arts and sciences are given insufficient emphasis. In particular, quite a few members have argued for broadening the multi-disciplinary range of the membership, as well as seeking more emphasis on the humanities, values, ethics, and emotions in our work. The so-called “rational person” model of human behavior has long been challenged in many socio-behavioral science disciplines

The present Colloquium is sponsored by the ARNOVA VALUES SECTION (Values, Religion, Altruism, and Drawbacks Section/VRADS), which has a very central concern about perceived excessive narrowness of themes, often ignoring a wide range of global research and theory in the Arts and Sciences in universities. This session invites thinking and discussion about dilemmas and possible futures of ARNOVA and of the broader interdisciplinary field of nonprofit and voluntary sector studies, now sometimes referred to as *voluntaristic*.
